Dear Sir,

Ministry of Religious Affairs is pleased to offer you enrollment as Hajj Group Organizer(HGO) for Hajj-2010 and provisionally allocate 145 seats under category C for the pilgrims who intend to perform Hajj-2010 under HGO scheme, subject to provision of following documents:-

i) Draft of Cash Guarantee @ Rs 20,000 per haji drawn in favour of "MORA" to be deposited in the Bank before issuance of Hajj application Forms.

OR

ii) Draft of Contribution for Hujjaj Compensation Fund @ Rs.5,000 per haji drawn in favour of "Hujjaj Compensation Fund" to be deposited in the Bank before issuance of Hajj application Forms.

iii) Summary Form (available on website and Hajj Directorate) duly filled alongwith its required documents.

2. Hajj application Forms may be obtained from the respective bank opted by you on submission of this letter. These forms, duly completed in all respects, alongwith **Summary Form** (available at Hajj Directorate and website i.e www.hajjinfo.org) **must be submitted with the same bank latest by August 16th, 2010** positively. Documents received after due date will be subject to financial penalty as per clause No. 21 of Service Provider Agreement (SPA) and Ministry have the right to withdraw its offer of quota.

3. This is just an offer letter, which may not be construed as grant of license as Hajj Group Organizer for hajj-2010. However, a formal Recognition Letter for grant of actual Hajj quota will be issued on completion/fulfillment of above formalities within stipulated time frame.
